- Q. And the others? You said "some had guns". What about the others?
- 3 A. The others, some had cutlasses and some were just civilians who had
- 4 just been captured.
- 11:07:02 5 Q. What about you, Madam Witness, were you armed at this time?
 - 6 A. No.
 - 7 Q. Besides yourself, was anyone else captured on that day around
 - 8 Consider Lane area?
 - 9 A. Yes.
- 11:07:25 10 Q. About how many others were captured?
 - 11 A. Where I was, they captured six of us.
 - 12 Q. Can you tell me the gender composition of this group of six people
 - who were captured?
 - 14 A. Yes, four were men; three women; and a young child about six years;
- 11:08:06 **15** and two boys.
 - 16 Q. What was the age range of the six people who were captured? There
 - was somebody who was six years old, what about the others?
 - 18 MR THOMPSON: Your Honour, before the witness answers that. My
 - 19 understanding is that there should be voice distortion in the public
- 11:08:38 20 gallery, but we're getting signals that they can't actually hear anything.
 - 21 PRESIDING JUDGE: I see. I was told that there was distortion in the
 - 22 public gallery. Madam Court Attendant, would you please check the
 - 23 situation for us, if it's being transmitted there or not.
 - 24 MS EDMONDS: The microphone was switched off because the distortion
- 11:09:43 25 was not working, but it's now rectified.
 - 26 PRESIDING JUDGE: I'm seeing some nods from the public so it must be
 - 27 all right. Ms Stevens, please proceed.
 - 28 MS STEVENS:
 - 29 Q. Madam Witness, I was asking you about the ages of the other persons

- 1 who were captured with you. Could you tell us the age range as an
- 2 estimate?
- 3 A. For me, I was 16 years.
- 4 THE INTERPRETER: Her mic is not on, Your Honours.
- 11:10:19 5 PRESIDING JUDGE: Madam Court Attendant, please make sure the
 - 6 witness's mic is on. I think that may have been my fault. I may have
 - 7 inadvertently turned it off.
 - 8 THE INTERPRETER: It's on now.
 - 9 PRESIDING JUDGE: Please proceed.
- 11:10:34 **10 MS STEVENS:**
 - 11 Q. Madam Witness, can you please respond to the question. You were 16
 - 12 years old?
 - 13 A. Yes. And the others were teenagers. I don't know their actual age.
 - 14 Q. Were any of these others who were captured with you armed at all?
- 11:11:04 **15** A. No.
 - 16 Q. What time of the day were you captured?
 - 17 A. It was in the afternoon.
 - 18 Q. After you were captured, did the rebels take you anywhere, Madam
 - 19 Witness?
- 11:11:19 **20** A. Yes.
 - 21 Q. Where did they take you?
 - 22 A. They took us to one place, but I don't know the place. Later we were
 - 23 brought to Allen Town.
 - 24 Q. Did you leave for Allen Town the same day that you were captured?
- 11:12:00 25 When did you leave Allen Town?
 - 26 A. The other day, the other morning.
 - 27 Q. To the place you don't recall being taken, when did you leave for
 - 28 that place?
 - 29 A. We went there on the very 22nd when they captured us.

- 1 Q. Now, after they captured you as you were being led away, did the
- 2 rebels say anything to you?
- 3 A. Yes. They are saying to us that they have captured us to use us as
- 4 human shields, that they were not going to harm us, and that we shouldn't
- 11:13:04 **5 be scared.**
 - 6 Q. Did they give anything to you at all?
 - 7 A. No. They gave us food. They gave us food.
 - 8 Q. Were you given anything to carry, Madam Witness?
 - 9 A. Yes. When they captured us, the boy who captured me, they gave me a
- 11:13:50 10 small school bag to carry.
 - 11 Q. Do you know what the contents of the school bag was, Madam Witness?
 - 12 A. It was later that I knew, when he opened it, that is when I knew what
 - 13 was in the bag.
 - 14 Q. What was in the bag?
- 11:14:18 15 A. A mat and a long lady's dress.
 - 16 Q. Do you know from where he obtained the lady's dress and the mat?
 - 17 A. No, I don't know.
 - 18 Q. When you were taken to Allen Town, did you find anyone at the place
 - 19 where you were taken to?
- 11:14:53 **20 A. Yes.**
 - 21 Q. Please tell this Court who was at Allen Town when you arrived there.
 - 22 A. When we reached Allen Town, we met the very rebels.
 - 23 Q. Are you able to tell us how many rebels you found at Allen Town?
 - 24 A. There were about 300 to 400, about that.
- 11:15:43 25 Q. Were these rebels armed at all?
 - 26 A. Yes.
 - Q. With what?
 - 28 A. With guns. Some had daggers, cutlass.
 - 29 Q. Apart from rebels, did you find anyone else at Allen Town at the

- 1 place where you had been taken?
- 2 A. Except those of us who were captured, we were the other people.
- 3 There were no other people there, except the rebels.
- 4 Q. Madam Witness, when you say except those of you who had been
- 11:16:39 5 captured, are you referring to the six of you who had been captured and
 - 6 taken there? Were you referring to another group?
 - 7 A. I'm talking about the other people, apart from the six of us, there
 - 8 were other people who had been captured.
 - 9 Q. Are you able to tell us roughly about how many people had been
- 11:17:06 **10 captured?**
 - 11 A. Well, those whom I was able to identify that had been captured, there
 - were about 100.
 - 13 Q. And these other civilians, apart from the six of you, these others
 - 14 who had been captured, were they in your group as you moved towards Allen
- 11:17:41 15 Town, or did you find them at Allen Town?
 - 16 A. Well, we met some there, and some were in our group when we were
 - 17 goi ng.
 - 18 Q. Can you help us with the gender composition of this larger group of
 - 19 people who had been abducted? Were there men, women --
- 11:18:24 20 PRESIDING JUDGE: Ms Stevens, I pause to say that we do not have
 - 21 direct evidence of abduction. She said "were captured" but we don't know
 - 22 if the whole 100 were. Be a little more careful with terminology.
 - 23 MS STEVENS:
 - Q. Madam Witness, you indicated about 100 more people had been captured.
- 11:18:50 25 Can you assist this Court with the gender composition of this 100 or so
 - people who had been captured?
 - 27 A. Well, the men were many. The women were more than the men, and there
 - were children amongst and elderly people.
 - 29 Q. Were any of these people armed?

- 1 A. No.
- 2 Q. Were they civilians or soldiers?
- 3 A. They were civilians.
- 4 Q. Do you know why these civilians were at Allen Town?
- 11:20:04 5 A. Yes, because they had captured them, that's why they were there.
 - 6 Q. Once you got to Allen Town, were you and the other civilians free to
 - 7 move around?
 - 8 A. No.
 - 9 Q. How was your movement restricted?
- 11:20:37 10 A. Well, they had some boys that they placed around. They called them
 - 11 SBUs. They had guns. They used them to prevent us from going anywhere.
 - 12 Q. Madam Witness, you used the term SBU. Do you know what that means,
 - or what it was meant to mean?
 - 14 A. Yes, yes. It meant Small Boys' Unit.
- 11:21:21 15 Q. Roughly, to the best of your knowledge, about how old were these
 - 16 boys?
 - 17 A. They were about 14 -- 13, 14, 15.
 - 18 Q. Do you remember about how many of them there were?
 - 19 A. With our own group, there were four of them who were around us to
- 11:21:58 20 prevent us from going away.
 - 21 Q. Now you made a reference to your specific group. Were there SBUs
 - 22 assigned to other groups as well?
 - 23 A. Yes.
 - 24 MR KNOOPS: Your Honour, excuse me. I must object. I didn't hear
- 11:22:28 **25** evidence on the existence of any other groups yet.
 - 26 PRESIDING JUDGE: The evidence is that there were six people that the
 - 27 witness was in and about a total of 100; ie 94 people. Is it the use of
 - the word "group" you're objecting to?
 - 29 MR KNOOPS: Yes, Your Honour, the terminology "other groups".

- 1 PRESIDING JUDGE: Ms Stevens, it's clear there were at least 94
- 2 people there. Reword that question, if you don't mind, please.
- 3 MS STEVENS:
- 4 Q. Madam Witness, you made specific reference to your group. Were there
- 11:23:07 5 other groups as well?
 - 6 A. Yes.
 - 7 Q. These groups that we are referring to, are we referring to groups of

 - 12 Q. Were there SBUs assigned to these other groups?

 - 16 Q. Whilst you were at Allen Town, did the rebels capture anyone?
 - 17 A. Yes.
 - 18 Q. Who did they capture?
 - 19 A. Well, they captured one boy whom they called Samuel. He was a
- 11:24:40 **20 ci vi l i an.**
 - 21 Q. Do you know why Samuel was captured?
 - 22 A. Yes.
 - Q. Why was he captured?
 - 24 A. When they captured him, they said he was a Kamajor.
- 11:25:09 **25 Q.** Do you know if the rebels did anything to Samuel?
 - 26 A. Yes.
 - Q. Please tell this Court what the rebels did to Samuel.
 - 28 A. They captured him and his two hands were chopped off and his tongue.
 - 29 Q. Did you observe this yourself, Madam Witness; were you present?

- 1 A. Yes, I saw it.
- 2 Q. Was this terrifying for you to watch?
- 3 A. Yes, I was terrified to see, but I was forced to look on, saying, now
- 4 who am I not to see when they are chopping off somebody's hand.
- 11:26:25 5 Q. Who forced you to watch as the rebels cut off Samuel's hands and his
 - 6 tongue?
 - 7 A. One of the rebels.
 - 8 Q. After Samuel's hands had been chopped off and his tongue cut up, did
 - 9 the rebels do anything to him?
- 11:27:07 10 A. Yes, they wrote a note, but I didn't know what was written, and they
 - 11 hung a bag on his neck and they placed the note in there and they told him
 - to go and tell ECOMOG that they would be returning, but they are not afar,
 - 13 they are around.
 - 14 0. Was Samuel released after that?
- 11:27:41 **15** A. Yes.
 - 16 Q. Now, you have indicated that altogether you spent three days at Allen
 - 17 Town. Where did you go after leaving Allen Town?
 - 18 A. Well, the person with whom I was took me and took me to Calaba town.
 - 19 Q. Madam Witness, we'll come back later to your statement just now about
- 11:28:28 20 the person whom you were with. You were taken to Calaba town; correct?
 - 21 A. Yes.
 - 22 Q. How long did you spend at Calaba Town?
 - 23 A. About three days.
 - Q. About how many of you went to Calaba Town?
- 11:29:11 **25** A. Three of us.
 - Q. Who were the other two?
 - 27 A. My cousin and my niece.
 - 28 Q. Who took you to Calaba Town?
 - 29 A. One of the rebels who had captured my cousin, he took me to Calaba.

- 1 Q. Is it fair to say that there were four of you then, including --
- 2 A. Yes.
- 3 Q. Where were the other rebels at this time?
- 4 A. They were around Allen Town. We moved down to Calaba Town where the
- 11:30:12 5 other rebels were.
 - 6 Q. Madam Witness, are you saying that once you got to Calaba Town you
 - found some more rebels; is that your statement?
 - 8 A. Yes.
 - 9 Q. And these rebels, were they armed?
- 11:30:48 **10** A. Yes, they had.
 - 11 Q. About how many of them were there, if you can recall?
 - 12 A. There were about 50 to 100, about that range.
 - 13 Q. Do you recall what they were wearing?
 - 14 A. Some had combat uniform and some had jeans and T-shirt.
- 11:31:29 15 Q. At this time at Calaba Town, were you in the custody of the person
 - who had captured you?
 - 17 A. No.
 - 18 MS STEVENS: Your Honours, I would seek leave of the Court, if there
 - 19 is no objection from the Defence, at this point to ask the witness to write
- 11:32:18 20 on a piece of paper the name of the person in whose custody she was at this
 - 21 point in time.
 - 22 PRESIDING JUDGE: Any objection?
 - 23 MR THOMPSON: Your Honour, I don't have any objection to that per se,
 - but she hasn't said she was in custody. She said she was not in the
- 11:32:39 25 custody of the person who captured her, so what exactly are we talking
 - 26 about?
 - 27 MS STEVENS: My next question would be --

- 2 MR THOMPSON: Her last sentence, Your Honour, was, "I not under the

 - 6 MS STEVENS: The question is going to be in whose custody she was and
 - 7 I was seeking leave for her to write the name prior to me asking that
 - 8 questi on.
 - 9 MR THOMPSON: Perhaps my learned friend's question should be was she
- 11:33:25 10 now in custody. We cannot just assume she went into custody again.
 - 11 JUDGE LUSSICK: I think you will have to get this evidence in
 - 12 sequence, Ms Stevens.
 - 13 MS STEVENS: Yes, Your Honours. I'm merely seeking leave for a piece
 - of paper to be given to the witness and a pen so that when she is asked to

 - 7 MS STEVENS: Your Honours, at this point, if I could just ask leave
 - 8 for the witness to indicate on the piece of paper the name of the rebel
 - 9 whom she went to Calaba Town with.
- 11:36:20 10 PRESIDING JUDGE: Just before we proceed, Madam Witness, are you
 - 11 feeling all right?
 - 12 THE WITNESS: Yes.

I have not yet dealt with the question of the Prosecution. Madam Court attendant, please have that document dated. 18 19 MR KNOOPS: Thank you, Your Honour. MR FOFANAH: Your Honours, can the witness sign the note as well. 11:43:27 **20** PRESIDING JUDGE: I did not direct that. 21 22 MR FOFANAH: We are simply asking that, Your Honour. 23 PRESIDING JUDGE: And I'm simply refusing. This is a protected 24 witness with a code. I will not have it signed. 11:44:06 **25** To deal with your point, Ms Stevens, this exhibit will be marked P1. The other exhibit I know is marked 1A and 1. I think perhaps I should 26 reclassify it as D1 and D1A. This will be P1. And Madam Court attendant, 27 will you please note that variation. I'm most grateful. 28

 - 7 marriage, marriage that is not legal.
