| | 3 | Honours to turn, for convenience, to the Defence bundle, tab 8: |
| | 4 | Q. You were asked some questions about your first statement |
| 16:10:16 | 5 | and stating you were in hiding after Sam Bockarie's death and at |
| | 6 | what point you came out of hiding. I am now going to read from, |
| | 7 | in the notes of the additional information from 31 October to 3 |
| | 8 | November, page 2, paragraph 12 and 13. Sir, there it says when |
| | 9 | Bockarie called you to come to the Ivory Coast you stayed there |
| 16:10:48 | 10 | for about a month or so. |
| | 11 | Excuse me. Let me just skip to paragraph 13. I think I |
| | 12 | called out the wrong paragraph. Paragraph 13. After the killing |
| | 13 | of Bockarie, Yeaten asked you what you would have done if you had |
| | 14 | been ordered to kill your chief Bockarie. You responded that you |
| 16:11:10 | 15 | would have followed the order of Yeaten because the only reason |
| | 16 | you were with Bockarie was because Yeaten had ordered you to be |
| | 17 | his bodyguard. Yeaten ordered that Bockarie's Sierra Leone men |
| | 18 | be killed and you yourself arrested two Sierra Leoneans who had |
| | 19 | come to Liberia with Bockarie. One was called the Toasty and you |
| 16:11:36 | 20 | can't remember the name of the other. You brought them to |
| | 21 | Yeaten. |
| | 22 | Then the next paragraph on the next page. You were |
| | 23 | assigned as one of the front line commanders around St Paul |
| | 24 | Bridge after the killing of Bockarie. There was fierce fighting |
| 16:11:51 | 25 | at that time against enemy forces trying to enter Monrovia. |
| | 26 | Later you moved to Saclapea which was cut off from Monrovia when |
| | 27 | the LURD took Gbarnga. Is that correct, sir? |
| | 28 | A. Yes, sir. |
| | 29 | Q. Sir, in the questioning of the Defence you were shown some |

- 1 photographs of persons around Charles Taylor and you said in some
- of those you recognised a diamond formation of close protection
- 3 and named some of the individuals. In one of those you named
- 4 Benjamin Yeaten as standing next to the President to President
- 16:12:42 5 Taylor. How tall was Benjamin Yeaten?
 - 6 A. Benjamin Yeaten and I have the same height.
 - 7 Q. You also were asked in one of the photographs you
 - 8 identified a man in a light suit you said was Musa N'jie. First
 - 9 of all, what is his nationality, if you know?
- 16:13:07 10 A. A Gambian.
 - 11 Q. And can you tell us approximately how tall he is, perhaps
 - 12 in referring to myself, if that helps you. In comparison to me
 - or anyone else in the courtroom.
 - 14 A. Musa N'jie is a bit taller than me. Not that all.
- 16:13:34 15 Q. Is he as tall as I am or the same height?
 - 16 A. No, no, no, you are taller than Musa N'jie.
 - 17 PRESIDING JUDGE: Before you move on, Mr Koumjian, for the
 - 18 record I don't know what height you are and neither does the
 - 19 record.
- 16:13:51 20 MR KOUMJIAN: Your Honour, at one time I was just under six
 - 21 foot one. I don't know if I've remained that tall.
 - 22 PRESIDING JUDGE: I think we will leave the record at that.
 - 23 MR KOUMJIAN:
 - 24 Q. Sir, on page 21119, line 3, you gave the following answer.
- 16:14:36 25 You said Jungle was the chief liaison officer between the RUF and
 - 26 the NPRG government. Sir, what did you mean what do you mean
 - 27 by the NPRG government?
 - 28 A. NPRAG, national patriotic party government. NPRAG.
 - 29 National patriotic party.

- 1 Q. What government is that?
- 2 A. It was Mr Taylor's government. So we used to say NPRAG.
- 3 But it was a rebel group. It was NPFL. But when Taylor became
- 4 President it became NPRAG government.
- 16:15:35 5 Q. Mr Witness, do you know which person or persons Jungle,
 - 6 Daniel Tamba, took orders from.
 - 7 A. Daniel Tamba used to take orders directly from Benjamin
 - 8 Yeaten and Mr Taylor.
 - 9 Q. Then I would like to refer you, sir, to excuse me, the
- 16:16:08 10 Court and counsel to page 21121 from yesterday beginning at line
 - 11 15. It's where you were talking about a uniform that you saw in
 - 12 a photograph and I believe you said that you recognised one of
 - 13 the people in the uniform. You said:
 - "This particular uniform, when Mr Taylor took over, when we
- 16:16:33 15 went to Monrovia for the very first time, it was the SSS that
 - 16 were using this black suit. But later it was turned over to the
 - 17 police and it was after that that we started using the navy blue
 - 18 and the blue in the SSS."
 - 19 I just want you to clarify, sir, if you can recall, when
- 16:16:54 20 was it approximately that the SSS was wearing the black uniform
 - 21 and when did they change? When were they wearing the black
 - 22 uniform as far as you can recall?
 - 23 A. When Mr Taylor first took over as President they issued
 - that black uniform to the motorcade with a green beret.
- 16:17:29 25 Q. Do you recall when it was that the SSS switched to the blue
 - 26 uni forms approximately?
 - 27 A. Yeah, we used the black uniform for about a period of three
 - 28 months and then we turned it over to the police.
 - 29 Q. Thank you. Now I would like to go to, I believe it's page

- 1 21044 of the same day's transcript, yesterday. At that time,
- 2 yesterday, you were being asked some questions about the
- 3 execution of Oliver Varney and some other names were mentioned by
- 4 you in your testimony. You were asked some questions about them
- 16:18:30 5 and you gave some answers. You were asked on line 12, 21044 if
 - 6 One Man One was arrested and you said:
 - 7 "No, they arrested De Gbun and others and later they
 - 8 arrested One Man One. One Man One was arrested after they had
 - 9 already executed Oliver and the others."
- 16:18:53 10 Sir, do you know what happened to One Man One after he was
 - 11 arrested? And if you don't know, just tell us.
 - 12 A. Yeah, I know what happened.
 - 13 Q. What happened?
 - 14 A. They killed him. Mr Taylor gave orders and they executed
- 16:19:11 **15 him**.
 - 16 Q. Just a few lines down you were asked about Anthony
 - 17 Mekunagbe. And forgive me if I mispronounce it. Mekunagbe?
 - 18 A. Yes.
 - 19 Q. And you said, "Anthony Mekunagbe, he was arrested later in
- 16:19:27 20 Lofa and at that time they had already killed Oliver and De
 - 21 Gbun". Do you know what happened to Anthony Mekunagbe after he
 - 22 was arrested?
 - 23 A. Yes, yes. After they arrested him Mr Taylor also gave an
 - 24 order and executed him and I was trying yesterday to name those
- 16:19:51 25 Gio and Mano who were executed but I was not given the chance.
 - 26 Q. Well, are there others that you haven't mentioned? Would
 - 27 you tell us now the names of others that you know were executed?
 - 28 A. Yeah. We are starting from Oliver. Oliver Varney. Yegbeh
 - 29 De Gbun. The late One Man One. The late Aloysius Menden. The

- 1 Late Anthony Mekunagbe. The Late Timothy Mulbah. The Late John
- 2 Yormi. The late Isaac Vaye. The late Cooper Teah. The late
- 3 Jackson F Doe. The late Ojuku Larry. The late Otis Klie. The
- 4 Late Cassius Jacobs. And so far Lirest. And the Late Joe Doe,
- 16:21:20 5 Special Forces. All of those people I've named were all Gio and
 - 6 Manos that were executed by Mr Taylor in cold blood.
 - 7 Q. How do you know that Mr Taylor was behind these executions?
 - 8 A. That was the order he used to give. And at the time that
 - 9 we were in Gbarnga and one more. The later Border Patrol,
- 16:21:54 10 Special Forces. At the time that we were in Gbarnga, when he
 - 11 gave the orders, these people were arrested. He will say that
 - 12 they wanted to connive, so they should be executed. That was how
 - 13 I came to know. He used to give the order live.
 - 14 Q. Who was Jackson F Doe?
- 16:22:17 15 A. Jackson F Doe was a former presidential candidate --
 - 16 THE INTERPRETER: Your Honours, can he repeat this answer.
 - 17 PRESIDING JUDGE: Mr Witness, your answer was not heard
 - 18 properly by the interpreters. Please repeat it. Start where you
 - 19 say, "Jackson F Doe was a former --" Complete from there.
- 16:22:45 20 THE WITNESS: I knew him to be the presidential Kennedy
 - 21 [sic] that was running against --
 - 22 PRESIDING JUDGE: I heard the word "candidate".
 - THE WITNESS: Candidate, candidate, yes, he had a party.
 - 24 PRESIDING JUDGE: I understand. Please continue.
- 16:23:08 25 THE WITNESS: He was one of the top men from Nimba and
 - 26 later when Mr Taylor came he was executed by Mr Taylor and also
 - 27 Samuel Doki.
 - JUDGE SEBUTINDE: Before we leave the point of the
 - 29 executions, the witness said, "He used to give the order live.

- 1 That is how I came to know". What does that mean, "He used to
- 2 give the order live"?
- 3 MR KOUMJIAN: Thank you.
- 4 JUDGE SEBUTINDE: I am not sure I understand.
- 16:23:40 5 MR KOUMJIAN:
 - 6 Q. Mr Witness, can you explain what you meant when you said he
 - 7 used to give the order live?
 - 8 A. When we were on duty at that time at Gbarnga, when we go to
 - 9 work he will tell Benjamin Yeaten that go and arrest so and so
- 16:23:58 10 persons, those people that I have just named. Sometimes they
 - 11 would send the task force or most of the units to arrest those
 - 12 people and they would bring them to Gbarnga. Some of them were
 - 13 brought to Gbarnga and they were killed and some of them, like
 - 14 Mekunagbe, he was killed in Lofa.
- 16:24:32 15 Q. Sir, I am going to try and go through some of the names.
 - 16 Some you have already given to us and some were new. I will see
 - 17 if you can help us with the spellings of some. If you cannot,
 - 18 you cannot. You said Isaac, and please restate the last name
 - 19 because I think it came out garbled. One of the persons
- 16:24:55 20 executed. I saac?
 - 21 A. I saac Vaye.
 - 22 Q. Do you know how to spell Vaye?
 - 23 A. V-A-Y-E.
 - 24 Q. You also said somebody named Menden or is that --
- 16:25:19 25 A. Yeah, I said Mr Taylor ordered.
 - 26 Q. I am just trying to get the names so we can write them
 - 27 correctly because these are all new to us.
 - 28 A. Yeah, no problem.
 - 29 Q. Can you repeat clearly, the name of Mr Menden?

- 1 A. Menden. M-E-N-D-E-N.
- 2 Q. Thank you. And Aloysius we will spell phonetically. Sir,
- 3 you said Cooper Teah. Do you know how to spell Teah?
- 4 A. Teah. T-E-A-H.
- 16:26:03 5 Q. You said another name I think we had earlier, but it was
 - 6 Larry 0j uku?
 - 7 A. Ojuku Larry. Ojuku.
 - 8 Q. Which is the family name? Do you understand? Which name
 - 9 is his first name and which is his last name, the family name?
- 16:26:24 10 A. His first name is Ojuku and his last name is Larry.
 - 11 Q. I wrote down that you said Joe --
 - 12 A. Joe Doe. D-0-E.
 - 13 Q. Thank you. I believe there were some others I didn't
 - 14 catch. Let's see if my colleague has got it. Somebody named
- 16:26:49 15 Clay, did you mention someone named --
 - 16 A. Cassi us Jacobs.
 - 17 Q. Did you say a name close to Otis Clay?
 - 18 A. Otis Klie. Klie.
 - 19 Q. How do you spell that last name? If you don't know, just
- 16:27:17 20 say so.
 - 21 A. It's supposed to be K-L-I-E, Klie.
 - 22 JUDGE SEBUTINDE: Was there a person called Border Patrol?
 - THE WITNESS: Yeah, yeah. A Special Forces, Border Patrol.
 - JUDGE SEBUTINDE: That was the full name Border Patrol
- 16:27:36 25 Special Forces?
 - THE WITNESS: That was the popular name that we used.
 - 27 JUDGE SEBUTINDE: Please listen to the question. Was the
 - 28 name Border Patrol Special Forces?
 - 29 THE WITNESS: Yeah.

- 1 JUDGE SEBUTINDE: All those four words?
- THE WITNESS: Yes.
- 3 MR KOUMJIAN: I am not sure you understand the question:
- 4 Q. Sir, how many words in that name?
- 16:28:03 5 A. Border Patrol. It's just one name.
 - 6 Q. When you said Special Forces, what did you mean? You said
 - 7 Border Patrol, Special Forces?
 - 8 A. He was one of Taylor's Special Forces that came along with
 - 9 him and his name was Border Patrol.
- 16:28:21 10 Q. Do you know his real name? If not, just tell us?
 - 11 A. No.
 - 12 JUDGE SEBUTINDE: The name after Oliver Varney was Yegbeh
 - 13 something.
 - 14 THE WITNESS: Yegbeh De Gbun.
- 16:28:46 15 MR KOUMJIAN: Thank you. I believe we have that De Gbun
 - 16 was one of the names mentioned in earlier testimony.
 - 17 PRESIDING JUDGE: Mr Koumjian, I think we are just about
 - 18 out of time.
 - 19 MR KOUMJIAN: Your Honours, could I just ask, I probably
- 16:28:59 20 have five or ten minutes left, at most ten minutes, if we could
 - 21 conclude the witness. If we have to change the tape, we change
 - the tape.
 - 23 PRESIDING JUDGE: Yes, we will allow that. If the tape can
 - 24 be changed, please. Although I note there may be some
- 16:29:16 25 applications and they may have to be deferred.
 - 26 MS IRURA: Your Honour, I am informed it will take five a
 - 27 maximum of ten minutes, but about five minutes.

29 MS IRURA: Your Honour, a new tape is in place.

- 1 PRESIDING JUDGE: Thank you for that.
- 2 MR KOUMJIAN: Thank you.
- 3 Q. Mr Witness, you gave a name that we understood as Timothy
- 4 something, do you recall did you mention someone named Timothy?
- 16:33:58 5 A. Yes.
 - 6 Q. Can you say the whole name clearly, slowly, please?
 - 7 A. The late Timothy Mulbah.
 - 8 Q. Could you help us by trying to spell that? If not, tell
 - 9 us.
- 16:34:17 10 A. Mul bah. M-U-L-B-A-H.
 - 11 Q. Then now I've lost the next name. John something?
 - 12 A. I said --
 - 13 PRESIDING JUDGE: If it's any help my notes are John
 - 14 Yombay.
- 16:35:21 **15** MR KOUMJIAN:
 - 16 Q. Did you say a name like John Yombay?
 - 17 A. I said John Yormi.
 - 18 MR KOUMJIAN: I believe we've had that spelling before,
 - 19 your Honours:
- 16:35:31 20 Q. Sir, just a few more questions. You said that when Oliver
 - 21 Varney was executed his body was left out. Why was it that
 - 22 no-one buried Oliver Varney's body?
 - 23 A. Me? The body was on the Bong Mines Road. We passed by, we
 - 24 stopped and I saw it.
- 16:35:59 25 Q. My question was, if you know, why was it that the body was
 - 26 left out there on the road and not buried, if you know?
 - 27 A. No, I don't know. The two bodies that I saw on the road, I
 - 28 did not know why they were left there.
 - 29 Q. Sir, I believe I only have one more question for you and

- 1 this is from yesterday's transcript, page 21118, line 27. At
- 2 line 25 the question to you was:
- 3 "Q. So Jungle was housed in Monrovia at Bockarie expense.
- 4 Jungle, a member of the RUF, was housed in Monrovia at
- Bockarie's expense, is that right?
 - 6 A. Yes. The RUF and the government, by then they were
 - 7 one."
 - 8 A. Yes.
 - 9 Q. Can you please explain to us, sir, exactly what you meant
- 16:37:08 10 when you said, "The RUF and the government, by then they were
 - 11 one"?
 - 12 A. They were one in the sense that any of the RUF commanders
 - 13 can come to Monrovia and any of the NPFL commanders could go to
 - 14 the RUF controlled areas and arms and ammunition were taken from
- 16:37:42 15 Liberia to RUF controlled areas, so everything was in line. So
 - 16 when the RUF comes to came to Liberia they had a special
 - 17 guesthouse for them where they used to stay.
 - 18 MR KOUMJIAN: Thank you, your Honour. That concludes the
 - 19 re-examination. I would be moving my exhibits into evidence. I
- 16:38:07 20 don't know it's necessary to keep the witness. I would say I
 - 21 have no objection to any of the Defence exhibits that have been
 - 22 marked for identification.
 - 23 MR GRIFFITHS: Madam President, I rise to make a request,
 - 24 please, that the schedule at the back of my --
- 16:38:42 25 PRESIDING JUDGE: Just before you do, Mr Griffiths, if it
 - 26 relates to exhibits could you please allow there are questions
 - 27 from the Bench, so if it's relating to exhibits if you could just
 - 28 pause.
 - 29 MR GRIFFITHS: I was just asking to mark for identification

- 1 the schedule.
- 2 PRESIDING JUDGE: I understand. There are two schedules.
- 3 There is this document and there is a document behind tab 11.
- 4 MR GRIFFITHS: Well, it's that document that I would ask to
- 16:39:11 5 be marked for identification.
 - 6 PRESIDING JUDGE: I understand, Mr Griffiths. That is a
 - 7 two page document headed "Table 1, schedule of interviews and
 - 8 payments". It becomes MFI-11.
 - 9 MR GRIFFITHS: Can I say, so far as we're concerned, the
- 16:39:32 10 photographs which were marked for identification during the
 - 11 course of this witness's examination-in-chief, I have no
 - 12 difficulty in those photographs being exhibited.
 - 13 JUDGE LUSSICK: Mr Witness, I have a question for you. I
 - 14 am trying to understand why you went around to the Defence office
- 16:39:56 15 to see Mr Gray so often. I think you told us you went there four
 - 16 times, didn't you?
 - 17 THE WITNESS: Yes, sir. Mr Gray sent for me.
 - 18 JUDGE LUSSICK: But I take it you had resolved not to give
 - 19 evidence for the Defence. Is that right? I take it you had made
- 16:40:26 20 up your mind that you were not going to give evidence for the
 - 21 Defence?
 - 22 THE WITNESS: Yes.
 - 23 JUDGE LUSSICK: So when Mr Gray sent for you why didn't you
 - 24 just say that to him, instead of going all the way around there.
- 16:40:42 25 THE WITNESS: They said they wanted to see me, sir, and I
 - 26 went, he repeated the same thing and I said, "No, I am not part
 - 27 of it" and I left and he said I should go and think about it
 - 28 agai n.
 - 29 JUDGE LUSSICK: But how did he contact you? Did he phone

- 1 you or send a messenger?
- THE WITNESS: He sent somebody to my house. Then, the
- 3 second one, he said we should hire a motorbike to go to the
- 4 office and we went, both of us, my friend whose name I called
- 16:41:22 5 today. Then --
 - 6 MR KOUMJIAN: I just recalled, are we in open session?
 - 7 PRESIDING JUDGE: Yes. He hadn't called a name.
 - 8 MR KOUMJIAN: Correct. But I think we should be for
 - 9 security. This area was covered in private session. I would
- 16:41:39 10 just submit that.
 - 11 JUDGE LUSSICK: I don't see any need, but if --
 - MR GRIFFITHS: I don't see any need for us to go into
 - 13 private session for this because you haven't mentioned any names
 - 14 at all, your Honour.
- 16:41:57 15 JUDGE LUSSICK: I don't intend to, either. Well, where
 - 16 were we? Had you finished answering that question?
 - 17 THE WITNESS: Yes.
 - 18 JUDGE LUSSICK: Well, did you have any idea, on each of
 - 19 these occasions, why Mr Gray wanted to see you.
- 16:42:29 20 THE WITNESS: Yes.
 - 21 JUDGE LUSSICK: Why not simply send a message back to him
 - 22 that you are not interested?
 - THE WITNESS: Yes, sir. This is why, for the last time
 - 24 that he called over the phone, I told him that I was not going
- 16:42:45 25 there, that I will not go to his office, because I tried to I
 - 26 was trying to avoid him for me not to be embarrassed, and he was
 - 27 trying to cajole me into giving a statement. Each time I went to
 - 28 him he would take out a copy book for them to write.
 - 29 JUDGE LUSSICK: That's what I can't understand. If you
