10 ID cards, which they took from the six people. Having shown it
11 to Johnny Paul, he said, "Let them be killed." Then Staff Alhaji
12 said the order have come, that they should kill them. Why I was
13 there now, I was crying from that of my friend. Then a soldier
14 came and asked me, why am I crying.

Q. Well, that is right, so this incident must be an incident
you remember very well, given that your friend was killed because
of Johnny Paul Koroma's order; is that right?

18 A. Yes, he gave the order. I know Staff Alhaji

19 [indiscernible] but if he had ordered their release, then they

would have released them, without killing them. But he said theyshould die and they killed them.

22 Q. Did Johnny Paul Koroma give that order; not so?

23 A. Yes. I was standing very close to his vehicle.

Q. Let's have a look at what you -- some notes from 14 days ago, same notes we referred to, paragraph 3, "Johnny Paul Koroma did not actually give the order for six civilians, including the witnesses to be killed -- the witness's friend to be killed. The order was given by Gullit, Superman and Savage, and the witness had heard it came from Johnny Paul Koroma." 14 days ago, do you

1 recall telling the Prosecution that the order came from Gullit 2 Superman and Savage? 3 What I'm telling you, at that time, they were all in that Α. 4 convoy; Gullit, Superman were in the same convoy. If anybody 5 should have died at that time, if he were to talk for you, you can be released, but he said nothing. 6 7 Q. Well, he did say something, according to you. According to 8 you, he said that the people should be killed. Isn't that what 9 you told us five minutes ago? 10 Α. If they would have given them mercy, they would have 11 released them, but they didn't give them that mercy, so the 12 people have to die. 13 Well, let's try to see through these different Q. 14 descriptions. Just pausing there, Mr Witness, who gave the order 15 for these six to be killed? 16 I have told you this, that when they brought those six men Α. 17 with those ID cards, they showed it to Staff Alhaji and he passed it to Johnny Paul, then he told that Johnny Paul had given the 18 19 order that they should be killed. 20 Q. So do you know why these notes from 14 days ago say, "The 21 order was given by Gullit, Superman and Savage." Do you know why 22 these notes say that? 23 The time when the order came, through Staff Alhaji, by Α. 24 then, a lot of executions have taken place in Tombodu, maybe that 25 is what you are referring to. Because Superman came and said, 26 "There is an order." I don't know. 27 Do you know why these notes from 14 days ago suggest that Q. 28 the order for the killing of the six civilians was given by Gullit, Superman and Savage? 29

1 Α. You know what, this man wants to confuse me. They killed 2 some people in Pa Fania's house. That is one area. When Mosquito sent the order that they should kill civilians, that was 3 the time that Gullit, Superman and Savage began killing people. 4 5 JUDGE ITOE: Mr Jordash, it is just about three minutes to. MR JORDASH: Your Honour, that is a convenient point to --6 7 JUDGE ITOE: You may just be winding up. Maybe ask him the last question or so before we go for break. 8 9 JUDGE BOUTET: But, Mr Jordash, I am looking at that 10 statement you are looking at and, in fairness to the witness, you 11 should carry on and read the remainder of that sentence. 12 MR JORDASH: Certainly, Your Honour. The sentence 13 beginning with "the order was given," Your Honour? Is that the one Your Honour is referring to, or the one after that? 14 JUDGE BOUTET: Yes, that sentence, the order was given, up 15 to Koroma. Up to and including Koroma. 16 17 MR JORDASH: This is what the notes say, Mr Witness: "The order was 18 Q. 19 given by Gullit, Superman and Savage and the witness had heard it 20 came from Johnny Paul Koroma." Is that what you told the 21 Prosecution 14 days ago, Mr Witness? 22 For the six people who were killed in Fania's compound? Α. 23 Q. That is what we're talking about. 24 Apart from the six people, that is far different from Α. 25 Superman's and Savage's order. We will come to that. That is a 26 different issue. 27 You are right, but I want to stick with this for one minute Q. 28 before we break for lunch. Let me read it again. "Johnny Paul 29 Koroma did not actually give the order for six civilians,

1 including the witness's brother to be killed" --2 MR HARRISON: That's what we're concerned about. 3 Mr Jordash had it right the first time, with respect to the 4 witness protection measure. 5 MR JORDASH: I beg your pardon. That's my fault. I'm very sorry. Actually I don't think this witness -- the name, which 6 7 hasn't been mentioned, of the alleged victim is, in fact, this 8 witness's relation. I think it is simply an expression of 9 speech. That is how I read it, but I take the point. We can deal will with that in closed session. 10 11 JUDGE BOUTET: I think we should expand on that in a closed 12 session. It would be easier. 13 MR JORDASH: Indeed. Yes, I am very sorry. It was a 14 complete accident. 15 One more question, witness. Just try to concentrate on it. Q. 16 Six civilians were killed. You say you knew one of them. The 17 notes taken from a meeting with you 14 days ago say this: "Johnny Paul Koroma did not actually give the order for six 18 19 civilians, including the witness's brother to be killed. The 20 order was given by Gullit, Superman and Savage, and the witness 21 had heard it came from Johnny Paul Koroma." 22 Is that what you told the Prosecution 14 days ago? 23 Α. Those six people that were killed, is a different issue, 24 and you are telling me that among the six I have no blood 25 relations there. I have a blood relation. I don't just want to 26 give the name. 27 JUDGE BOUTET: Mr Witness, we don't want to speak about 28 this issue now. The question is not whether you knew that person 29 or not. The question has to do with who said that they should be

3 JUDGE ITOE: I'm not trying to say that you should not go 4 to the statements, but the testimony of this witness, so far, has 5 been consistent.
