- 6. JUDGE ITOE; Next case please.
- 7. THE CLERK OF COURT; Case No. SCSL 2003-08-I The
- 8. Prosecutor against Samuel Hinga Norman.
- 9. JUDGE ITOE; You are Samuel Hinga Norman. Mr. Chief
- 10. Samuel Hinga Norman sits down. You look very fit today. We are
- 11. meeting still in camera as you very well know. We have taken your
- 12. Plea, and we are convened today to understand ourselves and the
- 13. date of the hearing as you very well know the hearing will be
- 14. preceded by a pre-trial conference which should take place you know
- 15. any time after this. So basically we are here today in order to fix
- 16. the date or dates wherein we can be able to take the pre-trial
- 17. formalities and to eventually fix a date for the hearing of your matter
- 18. so with this preliminary explanation I wonder if your Counsel has any
- 19. observations to make.
- 20. MR. JENKINS-JOHNSTON; Not really my Lord, the only thing I do
- 21. have to say is that I had a long interview with my client this morning and

1. he has instructed me to make a formal protest to the court 2. because he feels that he is being treated differently to the other 3. .accused persons in that his own pre-trial and proceedings are 4. being held in camera. So far no good reason has been proffered 5. in my view for his being treated differently and indeed my Lord 6. members of the Press were asking so many questions of me as to 7. why Chief Norman is being put in a different category to the other 8. accused persons. So my Lord that is my representation. I do hope 9. that after today we will also have the benefit of being heard in 10. public like everybody else. Those are my instructions my Lord. 11. JUDGE ITOE; Thank you. Well the court has taken of the 12. protest in the way you put it. This was a provisional order that 13. was made and it could be ruled out, that this order could be 14. retracted at one time or the other but I would like to say here that 15. we do not want to be discriminatory in our treatment to any accused 16. person that appears before us and any order we have made 17. particularly in respect of your client is made in the overall interest to 18. serve the overall interest of justice. At least the way we perceive it at 19. this time. We know your client to be a responsible person and we have 20. made this order in full recognition of his status in society and we have 21. addressed our minds you know to all the surrounding issues as far as

1..... this case is concerned and we think at this stage that whatever has been

2. done, has done in the interest of justice and I think having made 3. the order in his own interest. It isn't far from being a 4. discriminatory measure, it is a measure that comes within the 5. competence you know of the court and it is made in the overall 6. interest of justice. We have taken note of your observation and as 7. I said, orders come and go. I am not saying this one has come and 8. not to go. We have a disease in Cameroon that we call "cam nor go", 9. when it comes it never goes so this is not the nature of my order and 10. and I think that any other Judge or the trial Chamber when the time 11. will examine an application. In this regard may have to review this 12. order. So I hope that your client understands what I have said. He 13. has been following very, very well and I hope that he appreciates 14. while this order remains. 15. As I said this morning, we were to set a calendar you know for the 16. Pre-trial formalities and eventually the date of the trial and since we 17. cannot possibly advance any date for now I am sure the Prosecution 18. and you for the Defence are with me if I made the same order that I 19. made in previous cases for the Registrar to consult all the parties 20. concerned and to fix the date and inform the Court of when the 21. proceedings in one way or the other you know would come for a

- 1. determination. So this matter stands adjourned to a date that will
- 2. be fixed by the Registrar in consultation with the
- 3. Prosecution and the Defence for the purposes of
- 4. fixing a date for the pre-trial conference and eventually
- 5. a date for the hearing. These dates will be communicated
- 6. to all parties and we shall all meet either in camera or in open
- 7. court as the case may be.
- 8. MR. JENKINS-JOHNSTON; Hopefully no more in camera
- 9. my Lord.
- 10. JUDGE ITOE; The matter is accordingly so adjourned. Mr. Norman
- 11. You have understood my order.
- 12. THE ACCUSED; I did.
- 13. JUDGE ITOE; You will be informed by your Counsel on the evolution
- of the dates and when your further appearance would be required. But for
- 15. the time being you will remain in custody until when the matter finally
- 16. comes up before another Judge or myself or before a trial chamber. So
- 17. you will remain in custody but to this end you will have continued access

- 8. he has not been able to receive any member of his family, his wife and
- 9. children. They are very anxious to come and see him. The wife was with
- 10. me yesterday and he has asked me specifically to ask the Court when she

- 12. JUDGE ITOE; You will be surprised to know that we discussed this
- 13. matter with the Registrar yesterday and today just a couple of minutes
- ago. So I think he is looking into that and he would see what measures

- 16. course of when this can take place. Of course, you know it has to be
- 17. supervised visit. Right is there any other matter on the list?
- 18. THE CLERK OF COURT; No my Lord.
- 19. JUDGE ITOE; This session in camera is adjourned and I think we shall
- 20. only resume on a date that will please the Registrar to convene all of us.
- 21. So. Mr. Registrar we are at your mercy
